#### **OPEN TIME**

#### TREASURER'S REPORT

- Approve Check to City Treasurer for \$18,932 from operational account. (Water Bill)
- Approve eft payment to La Barre and Oxnee for insurance installment payments 5 of 8 installment for \$12,425.00 from the operational account.
- Approve eft payment to La Barre and Oxnee for insurance renal for General Liability for \$62,720.12 from the operational account.
- Approve reimbursement check for slab repairs to 54-Otero- in the Amount of \$10,000 from the operational account.

\*The Board practices oversight of significant financial and operational matters.

#### **MANAGER'S REPORT**

Ed updated the board that he has had communication with the SDUSD. The district is working with ED to see if they can schedule an annual commitment to maintain the area.

The last portion of the insurance refund has been received.

The painting project continues to be on hold.

With the pools getting busier, be aware of the monitors checking pool cards more often.
