A motion was made, seconded, and carried to approve the July 2025 general minutes with additional changes supplied by a board member.

#### **OPEN TIME**

A homeowner asked about pool toys and flotation devices in the pools. Randy clarified that only Coast Guard-approved flotation devices are allowed in the pool. He also suggested that if homeowners would like to update what is allowed, a committee could be put together.

Information about the number of surveillance cameras in the community was asked. The manager does not have an exact quantity, so an estimated number was given. Management reported that there are approximately 95 cameras and that the retention of video recycles about every two weeks.

A homeowner suggested to the Board that if a position becomes vacant after election, if the Board would appoint any write-ins or others running for the Board.

Portion of the refund from the insurance has been received and we are waiting for an additional refund. Once this has been received then the Board will be able to determine what the refund amount will be to the members.

Maintenance crew is on the roofs evaluating the condition of the roofs including those with panels.

The monitors are checking pool cards more frequently while using their body cameras as well.
