Ed reported that the landscape crew has completed the sod installation on Obra, Vera west and a few other areas in the complex. We will be pausing the sod project for now and monitor the water restrictions imposed by the State.

Due to the recently implemented water restrictions, we will be applying fertilizer and conditioner this week and most likely repeat this in August/September to help balance the water reduction. We are looking for three full time landscapers and have been using temporary workers until we can find replacements.

SOLAR PROJECT

Randy with Tier Drop solar said that the Solar panels on the recreation halls passed inspection and he has submitted the PTO to SDGE. The next phase is to submit the permits for the pergola's next month and order the steel.
